

AGREEMENT TO TERMS AND CONDITIONS

These Terms and Condition constitute a legally binding agreement made between you, whether personally or on behalf of an entity (“you”) and Audacity Performing Arts Academy (“Company”, “we”, “us”, or “our”), concerning your access to and use of the <https://audacityperformingartsacademy.com> website as well as any other media form, media channel, mobile website or mobile application related, linked, or otherwise connected thereto (collectively, the “Site”).
